HEALTH HAZARD DATA.

Skin: Immediately remove contaminated clothing, and wash with plenty of soap and water. Get medical attention if symptoms persist.

Inhalation: Remove patient to fresh air. Administer oxygen if breathing is difficult. Keep warm and quiet. Get medical attention.

Ingestion: Do not induce vomiting. Give patient milk or water to dilute. Immediately consult physician.

Medical Conditions Aggravated by Exposure: None generally recognized.

Chronic Health Hazards: Prolonged overexposure to solvent ingredients in section II may cause adverse effects to the liver, urinary, blood forming, cardiovascular, and reproductive systems. Reports have associated repeated and prolonged overexposure to solvents with permanent brain and nervous system damage.
